# Remote Patient Monitoring can bring a continuous, long-term stream of revenue for a practice.

Per CMS, providers who are eligible to bill evaluation and management codes can bill for Remote Patient Monitoring (RPM) services. Requirements to bill for RPM the patient must use appropriate devices; electronic data transfer is mandatory. SELF REPORTED DATA IS PROHIBITED. In order to bill 99457, the clinical staff and/or billing provider must provide some form of communication with the patient. In order to bill 99454, the patient must record at least sixteen days of measurements within a 30-day window.
