A Silver Lining On Inflation: Estate & Gift Tax Adjustments

Inflation can have negative effects, but it also has a positive side when it comes to federal tax breaks. For the 2023 tax year, many federal tax parameters have been adjusted upwards by about 7 percent compared to 2022.
