Local Team's Virtual Narcan Training Reaches Almost Half of All Texas

Lisa Cleveland, PhD, professor at the UT Health San Antonio School of Nursing, told KSAT TV in San Antonio that a state-supported program she leads at the school has provided virtual training to nearly half of all Texas counties on the proper use of naloxone, or Narcan, to reverse opioid overdoses, and reached all counties previously reporting opioid deaths. In addition, the program has distributed naloxone to 73% of all Texas counties.


