- Strongly supports the medical tort reform legislation that was passed in the Texas legislature and will work to be sure these effective laws are not diluted;
- Is an advocate for greater transparency by insurance companies and believes plans must disclose rules and payment methodologies to the public in order to provide better information to consumers on how they are spending their healthcare premium dollars, including how much is paid to their executives, shareholders, and owners;
- Staunch advocate of the principle that the patient care provided by physicians should not be influenced by hospitals or corporations and will work to defeat regulations that would interfere with the doctor-patient relationship;
- Supports the concept of a medical home for patients and will work to support this practice model. He also supports full disclosure of health care provider training and will work to stop the inappropriate expansion of practice scope by non-physicians.

Visionary

As we go through these changes in the health care delivery system, physician leaders will need to be challenged to think "outside of the box" and develop new payment mechanisms to ensure physicians do not become pawns of insurance, business, and hospitals. This is one of the major strengths of **David Henkes**.
